#### Loyalty Recognition Program Rules and Regulations

- In order to qualify for the program, purchaser must be the original Lindvest purchaser and principal resident of their current Lindvest home. Resale Lindvest homes do not qualify for this program.
- Loyalty program incentive must be used prior to closing.
- Lindvest shall have the right, at its sole discretion, to request current proof of ownership – your current home must be an H&R or Lindvest home to qualify.
- The purchaser will receive a loyalty program incentive for the amount specified, credited towards options and upgrades.
- Only one person per new home purchase is eligible to receive the loyalty program incentive.
- The loyalty program incentive may not be negotiated or transferred to another person.
- The loyalty program incentive has no cash value.
- Broker referrals do not apply if the purchaser is eligible for the loyalty program incentive.
- The loyalty program is in addition to and not in replacement of any existing or future Lindvest sales incentive bonus. Any Lindvest new home bonus will not cancel out or reduce in any way the loyalty program incentive entitlement.
- The home must be purchased and title taken in the same name(s) as the qualifying Agreement of Purchase and Sale (APS). This APS cannot be assigned or transferred prior to closing.
- Options for fully designated homes ("quick move-ins") may be limited—no cash value will be refunded for any un-redeemed coupon amount.
- Lindvest, in its sole discretion, reserves the right to alter or cancel the loyalty program at any time in whole or in part without prior notice.

Vendor reserves the right to limit availability of this program by project—see sales representative to confirm availability. This form must be completed and submitted at the time the Agreement of Purchase and Sale is entered into in order to be valid.
